Nebraska Ethanol Board - Advisory Board Member Appointment Application

On May 22nd, 2024, the Nebraska Ethanol Board (NEB or "the Board") approved new agency policy that allows for the appointment of advisory member positions. This was done to add expertise and foster consistency in the affairs of the Board.

Advisory members have long been integral contributors to the NEB, spearheading high-impact research projects, advising the Board on the feasibility of new projects and technologies, helping the Board engage with important stakeholders in Nebraska and nationally, and ultimately serving as go-to resources for the NEB Executive Director.

Advisory members are not considered when determining the presence of a quorum of Board members, and do not have voting rights. As such, they are only expected to attend at least two NEB meetings per year out of the typical quarterly meeting schedule. The appointment extends for one year following a vote of confirmation from the Board and may be renewed by the Board annually.

Applications for advisory board members will be reviewed by the NEB Personnel Subcommittee and candidates will be brought to the Board for a vote of confirmation at the next NEB meeting. The current application window is set between the dates of July 8th, 2024, and August 5th, 2024.
